

ORDINANCE No. 40/2025
of the Rector of the University of Wrocław
of 13 February 2025

**on the fees for educational services provided at the University of Wrocław for
the teaching cycles commencing on the academic year 2025/2026**

Pursuant to Article 23, section 1 and Article 79, section 1 of the Law of July 20, 2018. Law on Higher Education and Science (Journal of Laws 2024, item 1571, as amended), it is ordered as follows:

§ 1. This Ordinance sets the fees for the following educational services:

- 1/ the education of **Polish citizens and foreigners** in part-time studies conducted in the Polish language;
- 2/ repetition of classes due to unsatisfactory academic performance and for participation in classes not included in the study programme of full-time and part-time studies as well as full-time and part-time doctoral studies conducted in the Polish language for **Polish citizens and foreigners**;
- 3/ education of **foreigners** in full-time studies conducted in the Polish language;
education, repetition of classes due to unsatisfactory academic performance and for participation in classes not included in the study programme of full-time and part-time studies conducted in the English language for **Polish citizens and foreigners**;

§ 2.1. The amount of tuition fees for Polish citizens and foreigners in part-time studies conducted in the Polish language shall be determined by:

- 1/ Appendix **No. 1** at the Faculty of Letters;
- 2/ Appendix **No. 2** at the Faculty of Social Communication and Media Studies;
- 3/ Appendix **No. 3** at the Faculty of Historical and Pedagogical Sciences;
- 4/ Appendix **No. 4** at the Faculty of Social Sciences;
- 5/ Appendix **No. 5** at the Faculty of Languages, Literatures and Cultures;
- 6/ Appendix **No. 6** at the Faculty of Law, Administration and Economics.

2. The amount of tuition fees for Polish citizens and foreigners in part-time studies conducted in the Polish language shall be determined by:

- repetition of classes due to unsatisfactory academic performance,
- participation in courses not included in the study programme,
- established programme differences (courses to be completed) in the case of resuming studies, changing the form of studies or transferring from another university (**applies only to part-time studies**),

is set out in Appendix **No. 7** to this ordinance.

3. The amount of fees related to education of foreigners at full-time studies conducted in the Polish language is specified in Appendix **No. 8** to this ordinance.

4. The amount of fees related to education, repetition of classes due to unsatisfactory academic performance and for established programme differences (courses to be completed), in the case of resuming studies, changing the form of studies or transferring from another university or transferring from another field of study/specialisation as well as participating in classes not included in the curriculum of full-time and part-time studies conducted in English are specified in Appendix **No. 9** to this ordinance.

§ 3. Fees for full-time education of foreigners in the Polish language, as specified in Appendix **No. 8**, are not charged:

- 1/ citizens of a member state of the European Union, the Swiss Confederation or a member state of the European Free Trade Agreement (EFTA) - a party to the Agreement on the European

- Economic Area and members of their families, living in the territory of the Republic of Poland;
- 2/ a citizen of the United Kingdom of Great Britain and Northern Ireland referred to in Article 10(1)(b) or (d) of the Agreement on the Withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community (Official Journal of the EU L 29 of 31.01.2020, p. 7, as amended), and members of his family, living on the territory of the Republic of Poland,
 - 3/ persons with a valid Card of the Pole or persons to whom a decision (not an opinion) on the determination of Polish origin has been issued;
 - 4/ persons who have been granted a permanent residence permit (holders of a permanent residence card);
 - 5/ persons holding a long-term resident's residence permit of the European Union;
 - 6/ persons who have been granted a temporary residence permit in connection with the circumstances referred to in Article 159(1) or Article 186(1)(3) or (4) of the Act of 12 December 2013 on foreigners (this specific provision must be indicated on the decision granting the permit);
 - 7/ persons having the status of refugee granted in the Republic of Poland or enjoying temporary or subsidiary protection on the territory of the Republic of Poland (holders of a residence card with the annotation "refugee" or a decision on its granting);
 - 8/ persons holding a certificate attesting to their knowledge of Polish as a foreign language at least at language proficiency level C1. The only authorising document is a certificate issued by the State Commission for the Certification of Proficiency in Polish as a Foreign Language;
 - 9/ persons who are the spouse, ascendant or descendant (child, grandchild), of a citizen of the Republic of Poland, residing on the territory of Poland;
 - 10/ persons who have been granted a temporary residence permit for the purpose of scientific research (Article 151(1) of the Act of 12 December 2013 on foreigners - this specific provision must be indicated on the decision granting the permit);
 - 11/ persons who have been granted a temporary residence permit for the purpose of long-term mobility of a researcher (Article 151b(1) of the Act of 12 December 2013 on foreigners - this specific provision must be indicated on the decision granting the permit);
 - 12/ persons residing on the territory of the Republic of Poland in connection with the use of short-term mobility of a researcher under the conditions set out in Article 156b(1) of the Act of 12 December 2013 on foreigners - this specific provision must be indicated on the decision on granting the permit;
 - 13/ persons holding a national visa to carry out scientific research or development work.

§ 4. The amount of the semester fees for basic physical education classes and the didactic offer including away-weekend classes and sports and recreational camps, fully paid by the student, implemented as part of the physical education credit, is specified in Appendix **No. 10** to this Ordinance.

§ 5. Supervision of the implementation of this ordinance is entrusted to the Vice-Rector for Teaching.

§ 6. The Ordinance shall come into effect as of the date of signature.

- I. The fee for one semester is half of the annual fee.
- II. Polish citizens can pay fees in PLN.
- III. Foreigners, from the second year of study, can pay fees in PLN.
- IV. The fee for the repetition of classes due to unsatisfactory academic performance is **EUR 5** or the equivalent in PLN per hour of instruction. The total fees for repeating classes in a given grading period cannot exceed the tuition for that period.
- V. The fee for participation in classes not included in the study programme (applies only to classes at the Foreign Languages Centre and the School of Polish Language and Culture for Foreigners) is **EUR 5** or the equivalent in PLN per hour of classes.
- VI. The amount of the fee for established programme differences in the case of reactivation, change of the form of study or transfer from another university is **EUR 5** or the equivalent in PLN per hour of instruction.

The amount of the fee in PLN is established according to the average PLN/EUR exchange rate announced by **the President of the Public Procurement Office** in the current EU thresholds, their equivalents in PLN, the equivalents of the amounts expressed in EUR and the average PLN/EUR exchange rate being the basis for converting the value of public contracts or competitions - in the year of payment (information about the PLN/EUR exchange rate can also be found on the BIP website of the University <https://bip.uni.wroc.pl/516/288/sredni-kurs.html>).
